ARTICLES OF INCORPORATION

OF

PIB, SERVICES, INC.

THE UNDERSIGNED, have executed the following document for the purpose of forming the above named corporation under the Florida Business Corporation Act; and as incorporators hereby adopt the following articles of incorporation:

ARTICLE I NAME

The name of the Corporation shall be: PIB SERVICES, INC.

ARTICLE II DURATION

The Corporation shall exist perpetually unless dissolved according to law.

ARTICLE III CORPORATE PURPOSE

The corporation is being organized to act as an agent for insurance companies, to perform insurance audits, adjustments and visual fire and casualty inspections; and for the transaction of any lawful business permitted under the laws of the UNITED STATES OF AMERICA and the STATE OF FLORIDA.

ARTICLE IV CAPITAL STRUCTURE

The aggregate number of shares which the corporation shall have the authority to issue is the total sum of ONE THOUSAND (1000) shares of \$1.00 par value each. Unless otherwise stated in these articles, or in an amendment to these articles, there shall be only one (1) class of stock of this corporation.
