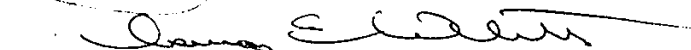

ARTICLES OF INCORPORATION
OF

ARTICLE ONE

The name of the corporation is SIGN SERVICE SYSTEMS, INC.

ARTICLE TWO

The period of its duration is perpetual.

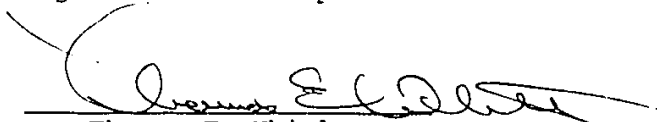

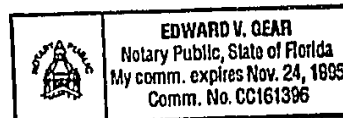
