# ARTICLES OF INCORPORATION

The undersigned incorporator hereby makes, subscribes to, acknowledges, and causes to be filed these Articles of Incorporation (hereinafter these "Articles") for the purpose of incorporating a corporation for profit under the Florida General Corporation Act, Chapter 607, Florida Statutes (1995).

#### ARTICLE I

# (Name of the Corporation)

The name of the corporation is AK Fiberglass, Inc. (hereinafter the "Corporation").

#### **ARTICLE II**

#### (Corporate Existence)

The time and date on which corporate existence of this Corporation shall begin is 12:01 A.M. (local time) on August 13, 1997, and this Corporation shall have continuous and perpetual existence thereafter.

# **ARTICLE III**
