The undersigned subscriber to these Articles of Incorporation, Troy Feltis, being a natural possory competent to contract, hereby acknowledges and files these ARTICLES OF INCORPORATION in the Office of the Color of the State of the State of Florida in order to form a Corporation for profit under the laws of the State of Florida.

ARTICLE I

CORPORATE NAME

The name of this Corporation is Go West Music, Inc. The principal office and mailing address of the corporation is 16323 South Tamiami Trail, Ft. Myers, Florida 33908.

ARTICLE II

DURATION

The Corporation shall have perpetual existence, commencing upon the date of filing of these Articles.
