OF

The undersigned subscriber to these Articles of Incorporation \overline{d} hereby subscribes to and forms a corporation for profit under the laws of the State of Florida.

Article I · Name

The name of the corporation is BAYTOWN CAR & TRUCK, INC. The principal office of the corporation is 2420 Frankford Avenue, Panama City, Florida 32405 and the mailing address is P. O. Box 27878, Panama City, Florida 32411.

Article II - Nature of Business

This corporation is organized for the purpose of transacting any or all lawful business.
