

### ARTICLES OF INCORPORATION

We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the statutes of the State of Florida providing for the formation, liability, rights, privileges and immunities of a corporation for profit in accordance with Florida Statutes Chapter 607, Florida Statutes as applicable.

### ARTICLE I

The name of the corporation shall be Amber Waves, Inc. The principal place of business of the Corporation shall be 101 North Gadsden Street, Tallahassee, Florida 32301.

### ARTICLE II

The purposes for which this corporation is formed is to acquire and operate a restaurant pursuant to the applicable Florida statutes.

### ARTICLE III

The address of the initial registered office of the corporation is 101 North Gadsden Street, Tallahassee, Florida 32301, and the name of its initial registered agent at such address is William B. Graham.

### ARTICLE IV

The period of this corporation's duration is perpetual existence.

### ARTICLE V

The number of directors constituting the initial board of directors is two (2), and the names and addresses of the persons who are to serve as directors until the first annual meeting of the shareholders or until their successors are elected and qualified are:

The number of directors of the corporation set forth above shall constitute the authorized number of directors until changed by an amendment of these articles of incorporation or by a bylaw duly adopted by vote or written consent of the holders of a majority of the then outstanding shares of stock in the corporation.

The total number of shares of all classes of stock which the corporation shall have authority to issue is one hundred (100) shares of common stock at One Dollar (\$1.00) par value each.

This Article can be amended only by the vote or written consent of the holders of fifty-one percent (51%) of the outstanding shares.
