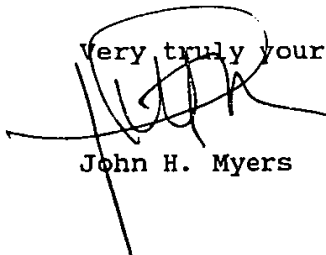

ARTICLES OF INCORPORATION

OF

SONDA INTERNATIONAL DIVERS, INC.

BY THESE ARTICLES OF INCORPORATION, the incorporators form a corporation for profit under Florida law.

NAME

The name of this corporation is SONDA INTERNATIONAL DIVERS, INC.

ADDRESS

The physical location of the corporation shall be at 3825 Sarasota Golf Club Blvd., Sarasota, FL 34240.

TERM

This corporation shall exist perpetually.

PURPOSE

The purpose of this corporation is to transact any or all lawful business for which corporations may be incorporated under Florida law.

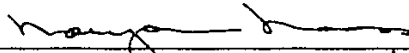

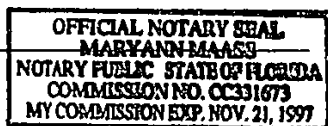
