Pursuant to the Florida Business Corporation Act, the undersigned incorporator of **Karniski & Delaney Enterprises, Inc.**, a Florida corporation (the "Corporation"), hereby adopts the following Articles of Incorporation for the Corporation:

**ARTICLE I
NAME AND ADDRESS**

The name of the Corporation is **Karniski & Delaney Enterprises, Inc.** The Corporation's principal office and mailing address is 3020 Azeele, Tampa, Florida 33609.

**ARTICLE II
BUSINESS AND ACTIVITIES**

The Corporation may, and is authorized to, engage in any activity or business now or hereafter permitted under the laws of the United States and of the State of Florida.

**ARTICLE III
CAPITAL STOCK**

The Corporation is authorized to issue 10,000 shares of Common Stock having a par value of \$0.01 per share.

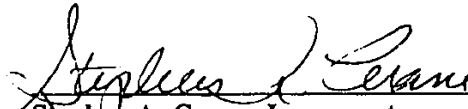
**ARTICLE V

The name and address of the Corporation's incorporator is Stephen A. Crane, 100 North Tampa Street, Suite 2700, Tampa, Florida 33602.

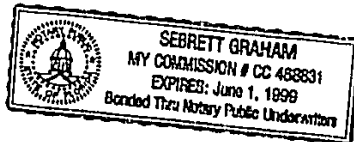

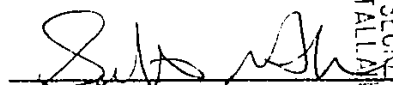
