ARTICLE 1 - NAME

The name of the Corporation is SUPREME NATURAL HERBS INTERPRISE, INC

ARTICLE 2 - DURATION

This Corporation shall have perpetual existence.

ARTICLE 3 - PURPOSE

The purpose of this Corporation is to engage in the transaction of any and all business permitted under the laws of the United States and of the State of Florida. TO MANUFACT & PRODUCE HEALTH PRODUCTS, COSMETIC, MARKETING/DISTRIBUTING, ADVERTISING & PROMOTION'S.

ARTICLE 4 - CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is 100 shares of common stock, each share having a 5.00 par value.
