The undersigned subscribers to these Articles of

Incorporation hereby forms a corporation under the laws of the

State of Florida.

ARTICLE I

The name of the corporation is: PARADISE ISLAND ENTERPRISES, INC., a new Florida Corporation. The mailing and business address of the corporation is 197 Stillwater Ct., Marco Island, FL 34145.

ARTICLE II

The general nature of the business to be transacted is all lawful business, including the authority:
