The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I

NAME

DURATION AND BEGINNING OF CORPORATE EXISTENCE

The corporation shall indemnify, to the full extent permitted by law, any officer, director, employee or agent of the

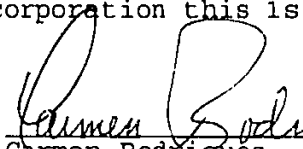
corporation authorized to take action on behalf of the corporation.

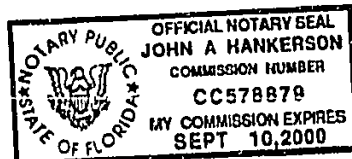

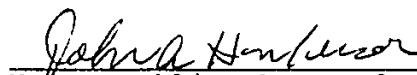
