The name of the corporation is Total Quality Cleaning Services, Inc.

This corporation is to exist perpetually.

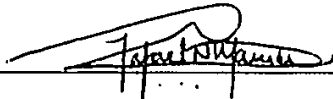

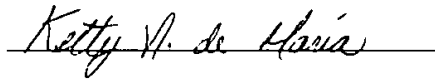

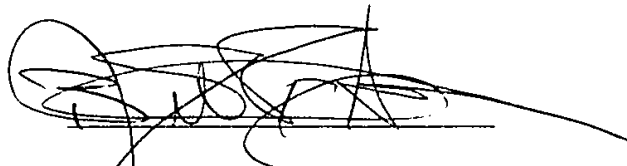
