# ARTICLES OF INCORPORATION OF EVENTUM CORP.

I, the undersigned, Amaury Cruz, Florida Bar No. 898244 hereby execute and acknowledge these Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida.

#### ARTICLE I NAME AND ADDRESS OF CORPORATION

The name and address of the corporation shall be: EVENTUM CORP., 6621 S.W. 8th Street, Miami, FL 33144.

# ARTICLE II DURATION OF CORPORATION

The duration of the Corporation is perpetual.

#### ARTICLE III PURPOSE

The corporation may engage in any activity or business permitted under the Laws of the United States of America and/or the State of Florida, as well as the laws of any foreign nation.

#### ARTICLE IV AUTHORIZED CAPITAL
