The undersigned, acting as incorporator pursuant to Chapter 607 of the Florida Statutes, adopts the following Articles of Incorporation:

Article I.

NAME

The name of this corporation is DIGITAL Orlando, Inc.

Article II.

ADDRESS

The street address of the principal office of the corporation is 2612 Bonneville Drive, Orlando, Florida 32826, and the mailing address of the corporation is the same.

Article III.

CAPITAL STOCK

This corporation is authorized to issue 10,000 shares of stock all of one class at a par value of \$1.00 per share, to be designated "common shares."

Article IV.

REGISTERED AGENT

INITIAL BOARD OF DIRECTORS


