
**ARTICLE X- INCORPORATOR**



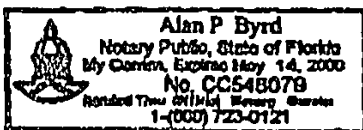
