

The undersigned subscribers, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation shall be: United Diagnostic Service, Inc.

The principal place of business of this corporation shall be 5462 Hoffner Avenue Suite 502 - 504 Orlando, Florida 32819

ARTICLE II: TERM OF EXISTENCE

The duration of this corporation is perpetual.

ARTICLE III: NATURE OF BUSINESS


