The undersigned, acting as subscriber of the corporation under the Florida Corporation Law, adopts the following Articles of Incorporation for such corporation:

**I.**

The name of the corporation is:





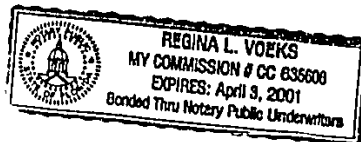
