ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of the professional corporation is RAUL J. LOPEZ,
L.C.S.W., P.A.

ARTICLE II - DURATION

This corporation is to exist perpetually.

ARTICLE III - PURPOSE

The general purpose for which this corporation is initially
organized shall be:

To engage in every phase and aspect of the business of
rendering the same professional services to the public that a
psychotherapist, duly licensed under the laws of the State of
Florida, and regulated by the Florida Department of Professional
Regulations, is authorized to render; but such professional services
shall be rendered only through its officers, employees and agents
who are duly licensed under the laws of the State of Florida to
practice such profession.

However, the foregoing purpose shall not be interpreted to
prohibit this corporation from investing its funds in real estate,
mortgages, stocks, bonds, or any other type of investments, or from
owning real and personal property necessary for the rendering of
professional services.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 100 shares of One
Dollar (\$1.00) par value common stock.

ARTICLE V - PREEMPTIVE RIGHTS

Every shareholder upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI - INITIAL REGISTERED OFFICE

The street address of the initial registered office of this Corporation is 777 East 25th Street, Suite 320, Hialeah, FL 33013.

ARTICLE VII - INITIAL REGISTERED AGENT

The power to adopt, alter, amend, or repeal by-laws shall be vested in the Board of Directors.

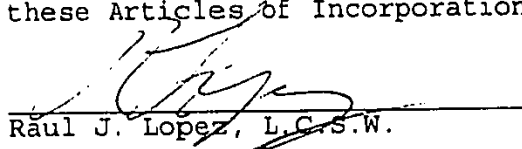
ARTICLE XII - INDEMNIFICATION

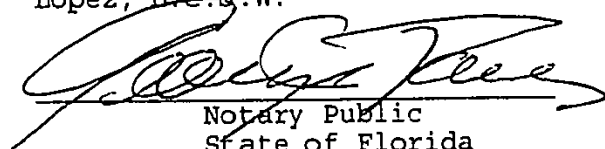

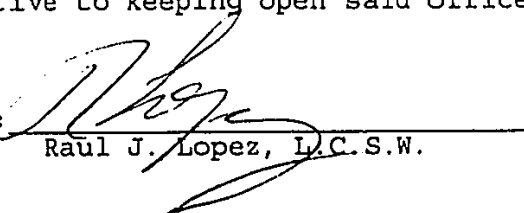
