ARTICLES OF INCORPORATION
OF

The undersigned, acting as Incorporators of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation:

1. **Name.** The name of this corporation is STAR FINDER, INC., and the mailing address is P.O. Box 1056, Alva, Florida 33920.
2. **Duration.** The period of its duration is perpetual, except as the same may be dissolved as provided by law.
3. **Purpose.** The purpose is to engage in any activities or business permitted under the laws of the United States and Florida.
4. **Capital Stock.** The corporation is authorized to issue ten thousand (10,000.00) shares, all of one class.

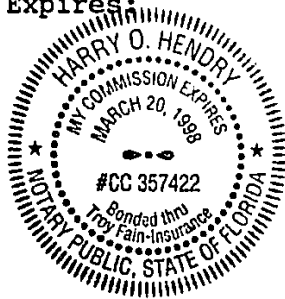
