ARTICLE 1: NAME AND MAILING ADDRESS

The name of this Corporation is P. MATTSON, INC., and its principal office or mailing address is 601 East Rosery Road, Apt. 3151, Largo, Florida 34640

ARTICLE 2: DURATION
