ARTICLES OF INCORPORATION
OF
SK1PCO INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act hereby adopt the following articles of incorporation:

ARTICLE ONE
NAME

The name of the corporation is: SK1PCO INC.

ARTICLE TWO
DURATION

This corporation shall commence existence immediately upon approval of the Secretary of State, State of Florida.
