# ARTICLES OF INCORPORATION

OF

# W. MORGAN SPEER, P.A.

The undersigned incorporator, who is licensed or otherwise legally authorized to practice law in the State of Florida, hereby proceeds to form a professional corporation in accordance with the Florida Professional Service Corporation and Limited Liability Company Act, and hereby adopts the following Articles of Incorporation for such Corporation.

## ARTICLE I

The name of this Corporation shall be W. Morgan Speer, P.A. The mailing address of this Corporation shall be 18 Via De Casas Sur, Number 202, Boynton Beach, FL 33426.

## **ARTICLE II**

The purpose of this Corporation and the general nature of its business are as follows:

- (a) To engage in the practice of law as a professional corporation and to provide services incident thereto.
  - (b) To own property, enter into contracts and carry on any activity

necessary or incidental to the accomplishment or furtherance of rendering professional legal services.

(c) To do everything necessary, proper or convenient for the accomplishment of any of the purposes herein set forth, and to do every other act incidental thereto which is not forbidden by the laws of the State of Florida or by the provisions of these Articles of Incorporation.

The services of this Corporation which consist of the practice of law shall be carried out only through officers, employees, and agents who are licensed or otherwise legally authorized to render professional legal services in the State of Florida.

## ARTICLE III

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time is One Thousand (1,000) shares of common stock having a nominal or par value of ONE DOLLAR (\$1.00) per share. None of the shares of this Corporation may be issued to anyone other than an individual who is duly licensed to practice law in the State of Florida or otherwise legally authorized to practice law in the State of Florida.

#### ARTICLE IV

The term of existence of this Corporation is perpetual.

#### ARTICLE V

The name and address of the person signing these Articles of

Incorporation as incorporator, who is duly licensed in the State of Florida to practice law is:

## ARTICLE VII

The Corporation shall be managed by a Board of Directors of at least one (1) Director. No person shall serve as a Director of this Corporation unless the person is duly licensed to practice law in the State of Florida or otherwise legally authorized to practice law in the State of Florida. # ARTICLE VIII

No shareholder may sell or transfer his or her shares in this Corporation except to another individual who is eligible to be a shareholder of this Corporation under Florida law.

## ARTICLE IX

If any officer, shareholder, agent or employee of the Corporation who has been rendering professional services for this Corporation becomes legally disqualified to render such professional services within Florida or accepts employment that places restrictions or limitations upon his or her continued rendering of such professional services, then this Corporation shall require him or her to comply with the Florida Professional Service Corporation and Limited Liability Company Act by severing all employment with and financial interests in this Corporation.

# ARTICLE X

These Articles of Incorporation may be amended in the manner provided by Florida law.
