The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the state of Florida.

**ARTICLE I. NAME**

The name of the corporation shall be: WEB SERVICES INTERNATIONAL, INC.

**ARTICLE II. NATURE OF BUSINESS**

This corporation may engage or transact in all lawful activities or business permitted under the laws of the United States, the state of Florida or any other state, county, territory or nation.

**ARTICLE III. SHARES**

The maximum shares of stock that this corporation is authorized to have outstanding at any one time is 15,000 shares of stock having \$1 value per share.

**ARTICLE IV. PRINCIPAL OFFICE**
