The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following articles of incorporation:

**ARTICLE ONE**

**NAME**

The name of the corporation is SS&F Health, Inc.

**ARTICLE TWO**

**DURATION**

The term of existence of the corporation is perpetual.

**ARTICLE THREE**

**PURPOSE**

The purpose for which the corporation is organized is to transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

**STOCK**

The aggregate number of shares which the corporation has authority to issue is 10,000, all of which shall be common shares with a par value of \$.50.


