The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

#### ARTICLE ONE

The name of the corporation is: ARH SPECIALTY TILE, INC. The principle address of the corporation is: 204 Foxtail Dr., Unit A1, W. Palm Beach, FL 33415.

#### **ARTICLE TWO**

This corporation shall commence its existence upon filing and shall exist perpetually thereafter unless sooner dissolved according to law.
