ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this corporation is SOUTHEASTERN EQUINE INVESTMENTS, INC..

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - CAPITAL STOCK


