





# ORDER ON RECEIVER'S INITIAL REPORT

THIS CAUSE came before the Court for hearing on December 30, 2002, upon the Receiver's Initial Report. The Court, having reviewed the Report and Supplement thereto, and hearing input from counsel and the Receiver, hereby

### ORDERS AND ADJUDGES that:

- 1. Pursuant to §§ 607.1430-1434, Fla. Stat. (2000), the Court hereby orders that Natural Systems Management, Inc. ("NSM"), shall be dissolved and directs the Receiver to take the appropriate steps to effectuate the dissolution.
- 2. The Receiver is further directed to pursue the claims procedures outlined in his Initial and Supplement Reports, as follows:

# For Claims Owed to NSM

a. NSM shall assign any claims involving related parties to the shareholders to pursue.

- b. For the claims involving unrelated entities, NSM shall demand payment from those holding outstanding invoices or an explanation of why payment should not be made.
- c. Once the demands have been made, the Receiver and parties shall seek further guidance from the Court, where needed, to determine if the claims are worth pursuing.

## For Claims Against NSM

- a. Any claims against NSM shall be resolved in accordance with § 607.1406, Fla. Stat. (2000), by providing notice to claimants who have unpaid bills and following the procedure set forth in § 607.1406, Fla. Stat. (2000).
- 3. For the derivative claims between the two sole shareholders of NSM, the Receiver is hereby directed to assign to the shareholder who believes that she has a claim, any such claim and let her pursue the claim, at her own expense individually, before the Court.
- 4. The parties are hereby directed to cooperate in good faith and assist the Receiver in carrying out his duties outlined in this Order.
