# ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF FRANK & LOWELL, INC.

Pursuant to the provisions of Section 607.1006, Florida Statutes, this corporation adopts a following articles of amendment to its articles of incorporation:

FIRST:

ARTICLE I and ARTICLE II of the Articles of Incorporation are amended by adding the underscored material and deleting the bracketed stricken out material to read as follows:

### **ARTICLE I**

The name of the corporation shall be and its address shall be

Its business shall be carried out in the State of Florida, in the United States of America, and elsewhere, as may be authorized by its Board of Directors.
