6. PURPOSE. The purpose of this corporation is to practice the profession of medicine.

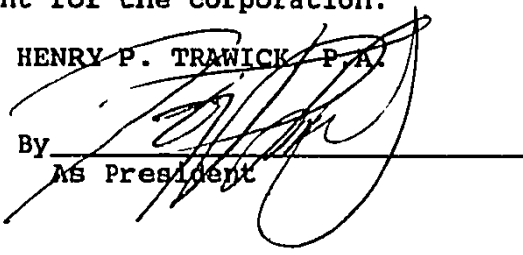
