The undersigned, acting as Incorporator of a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be WOOD ARTISTS, INC.

In no case shall these preemptive rights exist for a period in excess of 30 days from their first being offered to the shareholders.
