## Gentlemen:

Enclosed you will find the 1999 Profit Corporation Annual Report for Brinkerton, Inc. along with a check for \$150 made payable to the Department of State.

I realize that this filing is beyond the May 1, 1999 deadline for filing without a penalty, but I feel that the circumstances described below will allow you to abate the \$400 penalty that would otherwise be assessed.

The taxpayer, not recognizing the purpose of the form, forwarded it to our office along with her tax information. The information, however, reached our office on March 29<sup>th</sup> which was after we had extended her corporate return. As we were in the thick of 1040 tax season, the information was laid aside. A member of our professional staff did not review it until just before April 15 when we needed to estimate the shareholder's tax liability to file an extension for her individual return. The staff accountant was told by our tax manager to return the form to the client for her to file on or before May 1. The staff accountant failed to do so.

The staff accountant left our employ on June 10, 1999. At that time, the files in her office were distributed to other staff to be completed. The annual report packet was found at that time. Our office followed up with the client to see if she had replied to the 2<sup>nd</sup> notice on or before May 1, but since she had provided us with the 1<sup>st</sup> notice, she assumed that we had handled it and threw the 2<sup>nd</sup> notice away.

We have obtained the fee from the client and filed the report promptly after becoming aware of the oversight. As the client was unaware that the report had not been filed timely, we ask that you abate the \$400 penalty and accept the \$150 fee as submitted herewith.

Thank you in advance for your cooperation in this matter.
