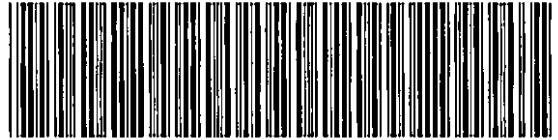



ARTICLE I


NAME
