## ARTICLES OF INCORPORATION OF Richard M. Tierney, P.A.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation pursuant to and in conformity with the Professional Service Corporation Act and other laws of the State of Florida.

#### ARTICLE I. NAME

The name of the corporation shall be: RICHARD M. TIERNEY, P.A.

The principal place of business of this corporation shall be: 1919-8 Blanding Boulevard, Jacksonville, Florida, 32210.

#### ARTICLE II. NATURE OF BUSINESS

The general purposes for which this corporation is organized and which are proposed to be transacted, promoted and carried on, are:

- 1. To engage, through its officers, employees and agents, who are duly licensed attorneys of law under the laws of the State of Florida, in every phase and aspect of rendering the same professional services to the general public that an Attorney of Law, duly licensed under the laws of the State of Florida, is authorized to render.
- 2. To own real or personal property as may be necessary for the rendering of professional services.
- 3. To invest the funds of the corporation in real estate, mortgages, stocks, bonds, or any type of investments.
- 4. To have one or more offices, in order to conduct its business and promote its objectives within the State of Florida.
- 5. To carry on and transact any business in connection with or auxiliary to the foregoing.
- 6. To have and exercise all of the powers conferred by the laws of Florida upon professional service corporations, and to do any of the things natural persons could do.

The foregoing clauses shall be construed both as objects and powers, and it is hereby expressly provided that the foregoing enumeration of specific powers of this corporation are intended as illustrative and not restrictive.

This corporation shall have the power to handle such business that may be necessary in conjunction with the business above enumerated.

This corporation shall have and exercise all powers, privileges and immunities of business of like kind and nature incorporated under the laws of the State of Florida, and

shall enjoy the privileges and immunities pertaining to incorporators under the laws of the State of Florida.

#### ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 500 shares of common stock having \$1.00 par value per share.

#### ARTICLE IV. ADDRESS

The street address of the initial registered office of the corporation shall be: 1919-8 Blanding Boulevard, Jacksonville, Florida 32210, and the name of the initial registered agent of the corporation at that address shall be Richard M. Tierney.

#### ARTICLE V. BOARD OF DIRECTORS

The Board of Directors shall manage all the business affairs of this corporation. This corporation shall have one Director initially. The number of Directors may be increased or decreased from time to time, by the By Laws.

#### ARTICLE VI. BY-LAWS

The power to adopt, alter, amend or repeal By Laws shall be vested in the Board of Directors and the Shareholders.

#### ARTICLE VII. TERM OR EXISTENCE

The corporation is to exist perpetually.

### **ARTICLE VIII. PREEMPTIVE RIGHTS**

Every shareholder, upon the sale for cash of any new stock of this corporation of the kind, class or series as that which he already holds, shall have the right to purchase his prorate share thereof at the price at which it is offered to others.

#### ARTICLE IX. SPECIAL PROVISION

It is the intent of the incorporator that the corporation will qualify under section 1244 of the Internal Revenue Code and that the corporation will file as an "S" Corporation.

#### ARTICLE X. OFFICERS
