Articles of Incorporation of Woerner East Marketing, Inc.

TATE AND PHILOSOPHICAL

The undersigned, acting as the sole incorporator, desiring to form a corporation for profit pursuant to the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE 1 - NAME OF CORPORATION

The name of the corporation shall be WOERNER EAST MARKETING, INC.

ARTICLE II - TERM OF EXISTENCE

The corporation shall begin its corporate existence as of the filing of these Articles of Incorporation and shall exist perpetually.

ARTICLE III - GENERAL PURPOSES
