The undersigned subscriber to these Articles of Incorporation, natural persons competent to contract hereby forms a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of this Corporation is UNITED FORCE, CORP.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS

The principal place of business and mailing address of this Corporation shall be: 11890 NW 87TH CT., BAY #7, HIALEAH GARDENS, FL 33016.

ARTICLE III - NATURE OF BUSINESS

The general nature of the business to be transacted by this Corporation is export & import of general goods and to carry on any lawful business or trade permitted under the laws of the United States and of the State of Florida.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is 100 shares of common stock of a par value of One Dollar (\$1.00).

Every original incorporating stockholder upon the sale for cash,

property or service or new shares or shares authorized but unissued, shall have the right to purchase his pro-rate share thereof at the price at which it is offered to others, which price, in case of par value shares may be in excess of par.

The transfer of shares may be restricted as provided for in the bylaws as adopted by stockholders or by other agreement between the parties thereto.

#### ARTICLE V - TIME OF EXISTENCE

This Corporation is to exist perpetually.


