The undersigned hereby forms a Corporation under the following Charter of Articles of Incorporation:

ARTICLE I

The name of this Corporation shall be J.C. ENTERTAINMENT, INC.

ARTICLE II

ARTICLE III

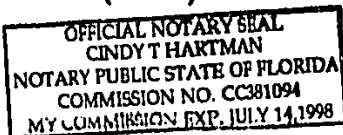
