

ARTICLES OF INCORPORATION FOR SECRE LARY OF STATE SPECTRUM GROUP INTERNATIONAL, INCLAHASSEE, FLORIDA

Pursuant to Chapter 607 of the Florida Statutes, the undersigned does hereby submit these Articles of Incorporation for the purpose of forming a profit corporation.

Article I - Name and Principal Office
