ARTICLE I. CORPORATE NAME

The name of the corporation is Central Florida Mobile Powerwash, Inc.. The mailing address of the corporation is 540 North Highway 434, Suite 530, Altamonte Springs, Florida 32714.

ARTICLE II. NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.
