1. Pursuant to Florida Statutes Sections 607.1003 and 607.1006, Article III of the Articles of Incorporation of the above-referenced Corporation is hereby amended to read as follows:

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time shall be One Million (1,000,000) shares of common stock having a par value of One Cent (\$0.01).

2. The foregoing amendment was adopted on March 25th, 1998, by written unanimous consent of all of the Directors and Shareholders entitled to vote on the amendment, in accordance with Florida Statutes Sections 607.0704 and 607.0821.

3. The amendment does not provide for an exchange, reclassification, or cancellation of stock.

4. The Secretary of State is hereby requested to approve and file these Articles of Amendment in accordance with Chapter 607, Florida Statutes.
