ARTICLE I - NAME

The name of this corporation is CSJ, Inc.

ARTICLE II - DURATION

The duration of this corporation is perpetual.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of owning, managing and holding real estate, and for any and all other lawful businesses.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 100 shares of ONE DOLLAR (\$1.00) par value common stock.

ARTICLE V - SECTION 1244 STOCK PLAN

This corporation is a small business corporation within the meaning of Section 1244 of the Internal Revenue Code. The corporation shall offer one hundred of its authorized common shares at a maximum consideration of \$500.00 per share, for a maximum amount of \$50,000.00. Payment of such stock shall be in the form

of cash or property; no stock shall be issued hereunder in exchange for stock, securities, or services.

ARTICLE VI - PREEMPTIVE RIGHTS

Each shareholder upon the sale for cash of any new stock of this corporation of the same kind, class, or series of that which he or she already holds, shall have the right to purchase his or her prorated share (as nearly as may be done without issuance of fractional shares) at the rate at which it is offered to others.

ARTICLE VII - PRINCIPAL OFFICE AND REGISTERED OFFICE AND AGENT

The principal address of this corporation is 3412 Edinburgh Drive, Pace, Santa Rosa County, Florida 32571. The name and address of the Registered Agent of this corporation is Jessie Aline Cutchens, at 3412 Edinburgh Drive, Pace, Santa Rosa County, FL 32571.

ARTICLE VIII - INITIAL BOARD OF DIRECTORS

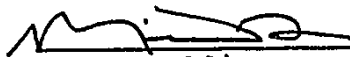
