Pursuant to Section 607.0202, Florida Statutes, these articles of incorporation provide that:

1. The name of the corporation is MK Marketing & Consulting, Inc. (the "Corporation").

3. The aggregate number of shares which the Corporation is authorized to issue is 1000 shares of Common Stock, par value \$1 per share.


