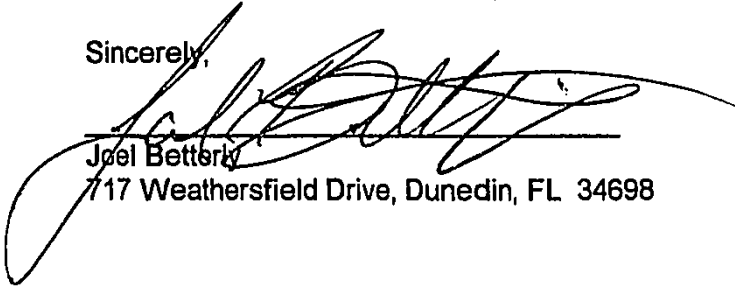

ARTICLE IV

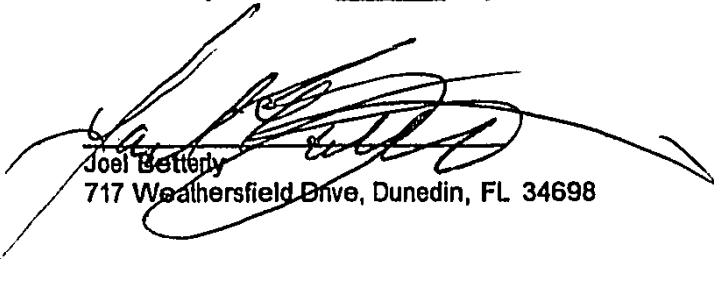
