ARTICLE I

NAME

The name of this corporation is Jamison-Johnson, Inc.

ARTICLE II

INITIAL REGISTERED OFFICE

ARTICLE III

COMMENCEMENT OF EXISTENCE

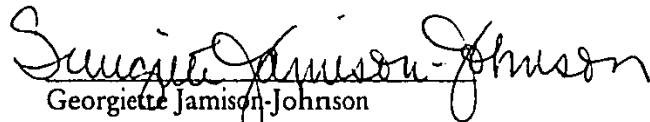

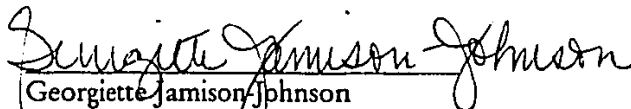
