ARTICLE ONE

The name of the corporation is Alpine Consulting Group TH, Inc. The principal office and mailing address is 550 Alexander Avenue, Deltona, Florida 32725.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.
