ARTICLES OF INCORPORATION OF HOMECARE REHAB SERVICES INC.

The undersigned incorporator hereby executes these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE 1

NAME

The name of this corporation shall be: HomeCare Rehab Services, Inc.

ARTICLE 2

PRINCIPAL OFFICE & MAILING ADDRESS

CAPITAL STOCK

- 1. <u>Authorized Capitalization</u>. The total number of shares of capital stock authorized to be issued by this Corporation shall be:
