THE UNDERSIGNED incorporator does hereby  
subscribe, acknowledge and file with the Department of State  
these Articles of Incorporation for the purpose of forming  
a Corporation for profit in accordance with the laws of the  
State of Florida.

ARTICLE I - NAME

The name of this Corporation shall be  
MARURI EQUIPMENTS CORP.

ARTICLE II - GENERAL NATURE OF BUSINESS

This Corporation may engage in any activity or  
business permitted under the laws of the United States of  
America and of the State of Florida

ARTICLE III - CAPITAL STOCK

the maximum number of shares of capital stock  
authorized to be issued by this Corporation shall be:

Each of said shares of stock shall entitle the holder there-

ARTICLE V - TERM OF CORPORATE EXISTENCE

The Corporation shall have perpetual existence.

ARTICLE VI - PRINCIPAL OFFICE

Any officer of the Corporation may be removed, without cause, at any annual or special meeting of the Board of Directors, where a quorum is present, by the affirmative vote of a majority of the Directors present.

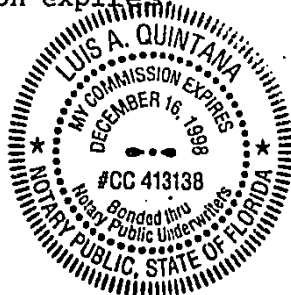
