ARTICLES OF DISSOLUTION

OF

STUART-PAINE, INC., a Florida corporation (the "Corporation"), by the undersigned, comprising a majority of the directors of said corporation, file these Articles of Dissolution pursuant to *Florida Statute* 607.1402, and state as follows:

- 1. The name of the corporation is **STUART-PAINE**, **INC**.
