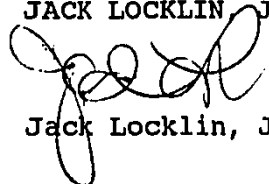

ARTICLE I

The name of this corporation is: GARY JERNIGAN BUILDERS, INC.

ARTICLE II

The term of existence of the corporation is perpetual.

ARTICLE III

ARTICLE IV - CAPITAL STOCK

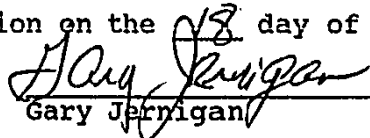
ARTICLE IX - BYLAWS

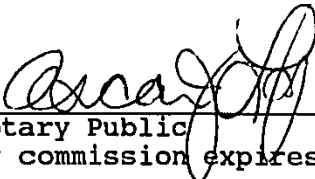
