SEPTEMBER PROJECT III CORP.


THE UNDERSIGNED, being the president of September

NAME


1. The name of this corporation shall be Fahrenheit

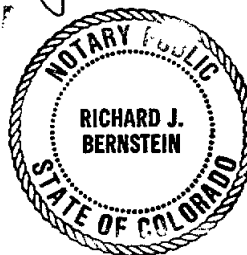
