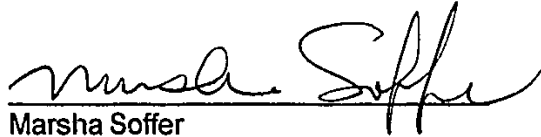
**ARTICLE IX

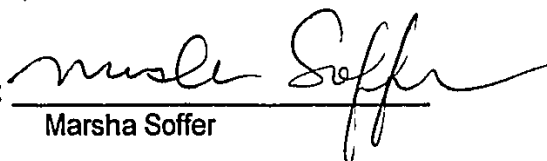
